Health Guarantee as follows:

This contract is valid for the original purchaser of the dog from Figgy's Cocktail Chihuahuas (Seller). If the dog is transferred to another owner then this contract is null and void, as Seller has no way of knowing how the dog is cared for or who the puppy is placed with. Buyer also must return signed copy of this contract in order for it to be valid with in 5 days from acquiring said puppy.

All dogs bred by Figgy's Cocktail Chihuahuas are AKC registered. Puppies will either be sold without AKC papers or If AKC papers are requested, we guarantee papers within 90 days of proof of spay or neuter, unless otherwise stated and agreed upon. If AKC papers are requested, they will be provided with Limited Registration status.

If a litter(s) is born from a dog (this puppy) sold as a pet (male or female producing the litter) even if it's "by accident" the litter and puppy/dog under this agreement becomes the possession of the seller or a fee of \$10,000 per litter. (seller's choice)

Figgy's Cocktail Chihuahuas has made every effort to provide you with a healthy puppy and guarantees that all vaccinations and dewormings are current at time of sale. A Health Certificate and a vaccination record will be provided as verification of events.

It is Buyer's responsibility to have this puppy examined by a licensed veterinarian of their choice within 5 days of taking possession of this puppy. If the puppy is found to have a life threatening congenital defect (heart, kidney, lung) or health problem at this exam, a replacement puppy of equal value will be given if available, if there is not a puppy available, then a 100% refund will be given, provided the seller is contacted immediately (within 24 hours) after the exam, and this puppy is promptly returned to the Seller.

Buyer understands that the following slight genetic defects are not considered serious or life-threatening, and therefore are not covered: umbilical hernia, undescended testicle, under bite or overbite, or cherry eye. Buyer understands that replacement option is only valid when health problems are attributed to a hereditary problem and not due to accident or contagious and/or other illness.

The puppy must return with a signed document from the veterinarian stating the defect and it will need to be discussed with a veterinarian of Sellers choice before any refund/exchange is granted. Seller is not responsible for illness or health problems that are diagnosed after this period.

Seller is not responsible for contagious diseases diagnosed after the above-mentioned examination of 5 days from the purchase date. Heat related illnesses, ear infections, eye infections, coccidiosis, or any disease that is brought on by neglect or poor nutrition is not covered.

Sellers will not be responsible for illness or death due to Hypoglycemia! Please read attached information sheet on hypoglycemia.

All medications and vaccines stated on pet's medical records are given by our Veterinarian. We are not responsible should an overload occur due to your veterinarian doubting our records, which can make the puppy sick. Please have your veterinarian call me if they question the vaccines 321-279-6456.

Sellers will not be responsible for Parvo or Distemper virus after 48 hours of the sale, as these are viral diseases, and they can be contracted immediately after leaving our facility. We implore common sense to the Buyer to not take the puppy to any public areas or around other puppies until the vaccination schedule has been completed.

Cosmetic issues that do not impact the puppy/dog's health are not covered. Hernias, under/overbites, collapsing tracheas, cherry eye, thyroid issues and luxating patellas for example are not considered life threatening and are not covered. Issues with patellas have been shown to be both hereditary or environmental (early injuries) Both parents of this puppy are clear of luxating patellas, heart conditions, hydrocephalus, allergies and eye conditions which are common issues with this breed.

Open fontanels in Chihuahuas is not considered a genetic fault and is thus not covered. Care must be provided that the puppy will not engage in rough play which could cause injury because of open fontanelles. Breeder is not responsible for injuries due to open fontanelles. The Seller assumes absolutely no responsibility for fees associated with veterinarian costs, caring or transportation of the puppy/dog once buyer takes possession of the puppy.

Seller further guarantees this puppy until one year of age (from date of birth) against life threatening congenital defects, (heart, kidney, lungs). If within that time period a life-threatening congenital defect is found, Seller will replace this puppy with another of the same breed, quality, sex. The replacement will be subject to availability (within 12 months). The return of the defective puppy will be required, along with the registration papers. Seller will not be responsible for illness or health problems that are diagnosed after this time period. In the unlikely event of this puppy's death in the first 12 months, due to a congenital defect, a statement from a veterinarian confirming such an event and cause is required before the Seller will take any action. If the cause is unknown, an autopsy is required at Buyers expense. Under no circumstances is this puppy to be euthanized without Seller's knowledge and consent. Under no circumstances will Seller be responsible for veterinary or medical bills incurred.

If the buyer requests a replacement puppy under the above-mentioned agreement and our veterinarian finds that the defect is not genetic, caused by an unrelated trauma, stress, neglect, abuse, or any non-inherited factor, this guarantee is null and void without effect and will not be honored by the Seller.

To be covered by this guarantee the said puppy must be owned by the person who originally purchased the said puppy from the Seller. The said puppy must have at all times received proper nutrition, current vaccinations, regular worm vaccinations including heart worm prevention, and yearly veterinarian visits. Also to be raised in a healthy living environment and proper exercise.

Seller is not obligated to refund any or the entire purchase price except as stated in conditions above. Violations of the terms of this contract renders all guarantees null and void and may result in the Buyer being required to return the puppy to the Seller at the Buyers expense. If the Buyer violates this agreement, the responsibility of any/all legal costs the Seller acquires enforcing this contract is to be paid by the Buyer.

There will be no refunds due to incompatibility, allergies, or landlord disputes. Please call us if you are having problems. We do not want to see one of our babies in an animal shelter. We will try to help you find a new home for them if the need arises.

Although we try to predict grown size and color, we do not guarantee either. We do not guarantee you will be able to show or breed your animal.

The Buyer shall provide the puppy with necessary veterinary care upon sickness, disease, or injury, and shall take it to a veterinarian at least once a year for an annual health examination and routine vaccinations.

The Buyer shall provide the puppy with humane care and maintain it in accordance with all current and future state, county, and municipal laws and ordinances where the Buyer resides or will reside.

If the Buyer cannot keep the puppy, the Buyer shall notify the Seller immediately. This puppy may never be sold or given away to any individual, company, research facility, or group except to the Seller - Figgy's Cocktail Chihuahuas.

The Seller HIGHLY SUGGESTS health insurance through Trupanion or other reputable dog health insurance companies to aid in normal health issues due to environment, aging, accidents, food, injuries and more. Information on instant coverage through Trupanion has been given to Buyer.
